ACCOMMODATION REGULATION "Gaudeamus" Centre for International Exchange

The purpose of this Regulation is to ensure the residents' hygiene, safety and tranquillity in the building, both in the locations for individual and for shared use, but also an optimum cohabitation between residents and a standard provision of shared services.

This Regulation legally binds all the residents who, as occupants of one of the rooms in the building, have accepted these conditions without restrictions. The residents will be held accountable for any actions performed by non-residents who enter the edifice under their responsibility.

This Regulation can be modified at any time, by the prior approval of the University Senate Board. Such alterations will be posted on the notice board in the building hallway and will be individually transmitted, in writing, to each resident. The residents are bound to keep the regulation without restrictions since the date they receive the notice.

"GAUDEAMUS" Centre for International Exchange offers accommodation to: students, teaching staff, PhD and Master's students who study at *Alexandru Ioan Cuza* University.

On accommodation, the student must fill out the Accommodation Contract and the residence permit application form.

The necessary accommodation documents are:

- Accommodation order (issued by the University);
- Accommodation Contract, filled out in two copies;
- One photograph (ID/passport type);
- Identification Document (for Romanian citizens);
- Passport (for foreign citizens);

Once the student takes hold of the room, he/she is bound to sign the minutes.

All room changes are performed between faculties.

Any individual renunciation of one's accommodation (with or without financial retribution) will not be allowed.

Art. 1: The shared goods in the residence halls and kitchens:

1. Students accommodated in the Centre are free to use the accommodation space and all the equipment therein, according to its destination; if any of the goods in the residence halls and kitchens is broken, students held responsible for its deterioration will be charged for the damage.
2. In case the person responsible for the damage is not disclosed, the damage will be laid to the charge of all students accommodated on the floor where the incident took place.
3. Once a week, on a previously established day for each floor, students must do the laundry and allow the residence personnel to clean their room.
4. Students must pick up their laundry as soon as it is removed from the washing machine.
5. Each balcony is provided with a laundry drier, which must be used for its destined purpose (no ropes attached to the balcony for the purpose of drying laundry will be allowed).
6. Smoking is allowed only in the smoking area.
7. Students must clean the kitchen equipment after using it.
8. The kitchen will be open until 10.00 p.m.

Art. 2: Visits received by the students accommodated in the Centre, payment of the accommodation fee, behaviour leading to noise:

1. Visits in the Centre may be received only until 11.00 p.m.
2. All visitors will leave an identification document at the Reception Desk and pick it up upon departure.
3. Visitors who stay overnight will be identified and charged with an accommodation fee for that night: 50 lei/night for the students and 80 lei/night for other persons.
4. The accommodation fee can be paid on a monthly basis or for several months in advance, during the 1st – 15th of each month.
5. Students who do not pay the accommodation fee in due time will be reported to the Faculty Dean and will be prohibited to give his/her exams at the end of the semester. They will also pay 1% penalties of the owed sum, for each day of delay, beginning with the 16th of the current month.
6. Students must keep down the music volume and the tone of their voices, both in the rooms and on the residence halls.
7. Parents and close relatives of the students accommodated in the Centre who request accommodation in student's rooms will pay the fees approved by the Senate Board, as requested.

Art. 3: Services offered by the “Gaudeamus” Restaurant:

1. Only students accommodated in the Centre may benefit from the restaurant's services.
2. Students may enter the restaurant only by showing their residence identification card.
3. Meals are served between:
 - Breakfast: 7.30 – 10.30 a.m.
 - Lunch: 12.30 – 15.30 p.m.
 - Dinner: 18.30 – 20.00 p.m., only upon request.
4. A food-VAT will be added for lunch and dinner: 42% for the students, 62% for teaching staff, 102% for visitors.

The **accommodation fees** for students registered at *Alexandru Ioan Cuza* University are as follows:

- for Romanian and foreign students registered at *Alexandru Ioan Cuza* University and for students registered at other public universities living in Gaudeamus residence: **490 lei / place in a room / month**;
- Romanian and foreign students who request accommodation for less than 30 days: **50 lei / place in a room / day**

The University will cover the rest of the full rate amounting to 700 RON / month / place

- Romanian and foreign students who request accommodation for less than 30 days: **50 lei/day/place in the room**
- PhD and distance-learning students: **50 lei/day/place in the room**

Hotel-type accommodation for other guests (e.g. foreign lecturers):

- one bed in a double room: **80 lei / day**
- a single room: **140 RON / day**
- a single room for periods longer than a month (foreign lecturers, teaching staff): **400 EUR / month**; for those who request accommodation for less than 30 days: **14 Euro/day** (breakfast not included)

Hotel-type accommodation fees add a 9% VAT, according to the fiscal current Romanian legislation.
