Main Goals

The project's scope is to advance the state-of-the-art research in the area of ageing migrants and welfare provisions. The project studies four dimensions:

- 1. The strategies developed by ageing migrants to access welfare provisions
- 2. The welfare policies and provisions (formal, informal or public, private and third sector) for ageing migrants
- 3. The informal and voluntary provisions by ageing migrants
- 4. Transnational ties and the links to welfare.

The data produced would serve to expand the knowledge base of welfare services capable to contribute to the well-being of ageing migrants in Switzerland and beyond.

Activities

- Internships in Geneva and Ia i
- Consulting the literature
- Identification and establishment contacts with Romanian migrants aged from Switzerland
- Access to Romanian institutions which can support the project with relevant informations
- Quantitative and qualitative research (interviews, questionnaires) in Switzerland and Romania
- Demographic and statistical analysis
- Participation in congresses, conferences, seminars in Romania, Switzerland, other countries
- Workshops with local stakeholders
- Articles and studies in peer-reviewed journals, individual and collective volumes
- International conferences

Expected results

The project will contribute to the knowledge production in this area by advancing the theoretical reflections on the topics of

- 1) ageing migrants,
- 2) the strategies of ageing migrants to access welfare provisions,
- 3) the articulation between public, private and third sector in the welfare provisions and
- 4) the role of ageing migrants in the provision of welfare. Just as important, the project will analyse in a comparative manner different groups of Romanian migrants in Switzerland, population that so far has been very little studied.
